David Strait called the meeting to order at 10:10am.

Minutes from the July 26, 2024 meeting were approved on a motion by Rod Kimble, seconded by Lesa Corley.

David Strait explained the County Commission has EMS Salary Enhancement funds for Crisis Response and open to suggestions from the first responder community on ways to utilize the funds. Official action on these funds would occur during a public county commission meeting.

Bob Wilkins discussed Chaplain services that he is willing to offer to the Barbour County Ambulance Authority and will prepare a draft agreement with expectations and services to present at the next meeting.

The mission statement for the Barbour County Ambulance Authority was discussed. Ideas will be presented at the next meeting.

The floor was open for public comment.

On a motion by Suzanna Skidmore, seconded by Rod Kimble, executive session was entered at 11:28am to discuss personnel.

Regular session resumed at 12:12pm on a motion by David Strait, seconded by Rod Kimble.

The next regular meeting will be held on September 13, 2024 at 10:00am.
