Laurie Austin presented a letter from Talbott Funeral Home regarding an outstanding account on the John Hayward Vest estate. The commission requested a certified letter be mailed to the heir of John Hayward Vest and allow 30 days to respond before taking action to appoint the Sheriff to the estate.

An in-house budget revision to the County Commission account was approved on a motion by David Strait, seconded by Jamie Carpenter. 3/0

A resolution was passed to support the Local Economic Development grant on a motion by Jedd Schola, seconded by David Strait. 3/0

A resolution was passed to accept the VOCA grant and allow the Commission President to sign necessary grant documents on a motion by David Strait, seconded by Jedd Schola. 3/0

David Strait amended a previous motion approving additional space for the Extension Service. They are changing their space occupancy resulting in a rent from previously approved \$920.33/mo to \$914.95/mo; Jedd Schola seconded. 3/0

A discussion was held regarding Judicial office space. David Strait made a motion to move forward with plans as presented and approved by the WV Supreme Court, Jedd Schola seconded. 3/0

A resolution supporting an application by the Barbour County Economic Development Authority for funds to enhance the Belington Industrial Park access road was tabled.

A request for a new road was received. On a motion by David Strait, seconded by Jedd Schola, Malcolm Farm Ln. was approved. 3/0

Corey Brandon submitted grant approvals on behalf of Barbour County LEPC including a Commodity Flow Study in the amount of \$6,550.00 and technical supplies through the LEPC Supplemental funding in the amount of \$1,500.00. David Strait made a motion to accept the grants and move forward with purchasing; Jedd Schola seconded. 3/0

Dylan Harper submitted a Homeland Security grant approval for an Asset Management System in the amount of \$11,910.12. Jedd Schola made a motion to accept the grant and move forward with purchasing; David Strait seconded. 3/0

Jedd Schola reported that he made contact with the CEO of Go Mart regarding the closure of the Belington Sheetz.
