With the approved Loss of Revenue replacement funding for expenses incurred as a result of 2021 fair cancelation due to COVID 19, we were able to start staffing our fair office for normal operation May through September. The additional funding enabled us to provide educational components that had to be elemenated or modified during the last two years of no fair. Third Grade Day and Educatonal Days brought several learning stations to our event.
