Chestnut Ridge Public Service District is submitting a Funds Request for a 2022 Ford Bronco, a 2022 Ford F-250, a Valve Operator Exerciser and Repair parts for the System.

Chestnut Ridge PSD currently does not have a truck to haul our Case Excavator to do line repairs and new taps. Our employees have been using their personal vehicle to move the excavator.

It is a requirement that Chestnut Ridge have a valve exercising program in place. Many of our valves are old and are going to be replaced. We will now be able to meet the requirements for an exercise program.

The Ford Bronco will be used by our second field employee for daily monitoring of Booster Pumps Stations and tank levels. It will also be used for meter reading if needed.

The CITCO Invoice is for repair parts that we need to repair lines when a leak occurs and pressure reducing valves and meter wells for new Tap installation or replace deteriorated ones.

We feel that these items will be sufficient to meet the needs of the District.

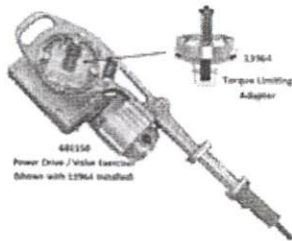
