Broaddus provides care (including Emergency Room and Long Term Care) to Barbour County and has served as emergency shelter during extended power outages. COVID has caused increased patient volumes especially during spikes in the positivity rate in the county. This has resulted in holding patients in the Emergnecy Room due to not being able to transfer to higher levels of care. Consistent electrical power must be maintained to provide necessary patient care.
