The Barbour County Commission received \$125,581.40 in EMS Salary Enhancement funds and tasked the Barbour County Ambulance Authority board to determine allocations. The Barbour County Ambulance Authority voted to reserve 10% (\$12,558.14) of the salary funds for recruitment purposes. Three employees will receive an additional stipend of \$4,000 each for performing additional Director duties during 2022. The remaining funds were distributed at \$38.41 per run in 2022. Criteria had to be met for employee eligibility of the funds including having at least 10 runs with the agency in 2022; be a current active employee of same agency, and not received EMS Salary Enhancement funds from another agency. If recruitment funds are not used by November 2024, the remaining will be distributed in the same manner. On a motion by Jedd Schola, seconded by Jamie Carpenter, \$38,762.76 will be distributed to Barbour County EMS and \$74,260.50 to Belington EMS and shall be distributed to employees as presented. 3/0

Quotes were presented for a Courthouse Maintenance side by side for snow removal and maintenance purposes. On a motion by Jamie Carpenter, seconded by Jedd Schola, a John Deere Gator was approved from Middletown Tractor Sales in the amount of \$31,865.00 3/0

On a motion by David Strait, seconded by Jamie Carpenter, materials were approved from Builder's Center in the amount of \$2,440.16 to replace the Cedar Shake shingles with lifetime architectural shingles. County Maintenance will complete the project. 3/0
