Cory Cox provided a 911 report with 1,625 calls for service and continued assistance to OEM for COVID-19 activity.

More information will be available at a later date. The free testing event held on October 31 was managed by the WV National Guard. There were 17 tests administered during this testing event.

The Century No. 1 Sewer project was discussed. The Commissioners had a beneficial walkthrough in the community with the contractor and PSD and now have a better understanding of the project. The Commission has complete confidence that Glenn Johnston will do a great job finishing up the project with lateral hookups. Quotes were requested for inspection services of the lateral hook ups. Following discussion, Tim McDaniel made a motion to approve the quote from Thrasher Engineering to allow Sammy Moran to carry out the inspection requirements.
